HUSBAND - Claude Bremeyer VanDervoort
 Lived with parents in 1880 and 1900 according to census.
 Mike Morrissey's notes give a date of birth of 1877.
 He worked briefly as a stock broker on Wall Street, probably when employed by Walter Luttggen, then later was the Superintendent of Luttggen's Villa Linta in Redding Ridge, CT, where he lived with his family.
 Died intestate. The house on Pole Bridge Road was left to wife Gertrude and daughter Tannis through probate.
 Tannis Walker was Administratrix.

WIFE - Gertrude Johnson
 She lived with her uncle John Dailey Jr. (RIN 855) and his wife Hannah(RIN 856) in 1896 at 327 Wharton St, Philadelphia after her graduation from Trenton State Normal School, Trento, New Jersey.
 Her obituary states she was born in Whig Lane, but a certified copy of the birth certificate issued March 10, 1958 states she was born in Upper Pittsgrove Township, Elmer, NJ with a birth date of Mar 20, 1879 and registration date of Mar 22, 1879.

CHILD 1 - Tannis Marjorie VanDervoort
 Baptism Certificate states she was Baptised into the Holy Catholic Church, but this must not mean the Roman Catholic church. The batism was held in Grace Church, which according to the book "Linden New Jersey was an Episcopal church purchased and relocated by her Uncle Walther Luttggen.
 Birth Certificate was issued by the State of New Jersey on Oct 1, 1945 subscribed and sworn in the court in Danbury, CT with birt date of May 1, 1906 and birthplace North Wood Hospital in Linden, NJ, so perhaps the original certificate no longer exists.
 There are letters certifying that she attended school, one from the Board of Education in Linden, NJ stating that she entered the 1st grade at school #1 in Linden, and one from the Superintendent of Schools in Bethel, CT stating that she entered the 8th grade at Bethel Center School in September 1919.
 Divorce awarded custody of Ross and Gary to Tannis with visitation to father, and \$50 each for monthly support.
 Letters and receipts show that she borrowed \$1200.00 from her cousin Mary Coates Martin Kupillas in 1970 and paid it off in 1977. She also borrowed \$200 from friends Harold and Alice Smith in 1976 and paid it off in 1977.
