Military info in a letter from Donald Walker dated 02/04/97. He got information from the Military Records of the National Archives of Canada. Canadian Soldiers of World War I, 1914-1918 also states his regiment number was 2265373. Birthplace and time noted in the same letter. Enlistment papers say he was born 02/04/1899 in Ingersol Ontario, but his death certificate states he was born 02/04/1900 in Sudbury, Ontario. He may have lied about his age so he could enlist

Birth registration researched by Jeff Stewart genealogical services. Source, Ontario Birth Registration #030100 (1900), records of the Office of the Registrar General, RG80-2-0-516, volume 12, page 638, microfilm MS929 reel 151, Archives of Ontario.  
1911 Census of Canada shows last name Blancher, which was probably an error by the census taker since his mother had remarried Fred Blancher.  
Border crossing document states that his departure contact was "step mother" Lottie Blancher. His arrival contact was a friend, R. K. Metcalf. He was accompanied by wife Bessie and son Donald. Destination was Springfield, MA to seek employment. His occupation was (auto?) supply dealer.  
Upon his death, an agreement was reached on Nov 7, 1960 between Natalie Walker and Tannis Walker and Donald Walker as guardian of the estates of Ross and Gary Walker that J Appleseed Farm would remain in ownership by Tannis Walker. It was stipulated that she could sell the property, but not leave it in a will to anyone else.  
Divorce awarded custody of Ross and Gary to Tannis with visitation to father, and \$50 each for monthly support.
